Written notice is to be mailed in the form of a certified with return receipt document to last known address as to the date of execution of this Agreement. Address change notice to other party is incumbent upon the party whose mailing address has changed and must be submitted within ten (10) days of said change. If written notice is provided following the 60 days NOC period, the annual contract total shall remain due & payable to the Contractor in accordance with this Agreement.
